## **RESOLUTION 2021-16**

A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE WEST VILLAGES IMPROVEMENT DISTRICT SUPPORTING THE PROCUREMENT OF STATE AND FEDERAL FUNDING FOR SAFETY AND TRANSPORTATION IMPROVEMENTS ALONG US 41.

**WHEREAS**, the West Villages Improvement District ("District") is a local unit of special purpose government created and existing pursuant to Chapter 2004-456, *Laws of Florida*, as amended (the "Act") located within the City of Northport and Sarasota County, Florida; and

WHEREAS, the District has approved various plans of improvement which provide for the District's responsibility to undertake, finance, fund, provide, and in some instances on and maintain, infrastructure improvements that benefit the lands located within the boundaries of the District; and

WHEREAS, the District has provided those collective improvements using a variety of funding sources including revenue bonds, landowner and developer contributions, state grant funds, and other legally available revenues; and

WHEREAS, the District has been advised about possible State and Federal level funding available to fund the safety and transportation improvement enhancements along United States 41 which may total as much as \$3,000,000 in the aggregate; and

WHEREAS, the District desires to authorize the District Manager, district staff, and other members of the development team representing the master developer for the community and such others as may be necessary to advocate on behalf of the District for the retention of such funds; and

WHEREAS, the District understands that such activities may be time sensitive in so far as the Florida Legislative Session begins in January 2022 and local legislative delegations and committees have already begun to meet; and

**WHEREAS**, to the extent that such efforts require expenditures on the part of the District, the District Chair is authorized to enter into a standard form funding agreement with the master developer or a related entity in order to provide the necessary funds for such efforts.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF THE WEST VILLAGES IMPROVEMENT DISTRICT:

**SECTION 1. AUTHORITY.** This Resolution is adopted pursuant to Chapter 189, *Florida Statutes* as well as Chapter 2004-456, *Laws of Florida*.

**SECTION 2. FINDINGS.** 

- (a) The recitals as listed above are found to be true and correct and are materially incorporated into this Resolution as set forth herein.
- (b) The procurement of such state and federal funds to provide additional traffic and safety enhancements along US 41 is hereby found to be a good and lawful public purpose and in the best interest of the District, its landowners, and residents.
- (c) The District Manager is authorized to proceed as outlined above and to utilize such landowner, District or other resources as may be appropriate to secure the pledge of the aforementioned state and federal revenues for the purposes listed above.
- (d) The Chair is authorized to execute a standard funding agreement to the extent necessary.

**SECTION 3. SEVERABILITY.** If any section or part of a section of this Resolution is declared invalid or unconstitutional, the validity, force and effect of any other section or part of a section of this Resolution shall not thereby be affected or impaired unless it clearly appears that such other section or part of a section of this Resolution is wholly unnecessarily dependent upon the section or part of a section so hard to be invalid or unconstitutional.

**SECTION 4. EFFECTIVE DATE.** This Resolution shall become effective upon its passage and shall remain in effect unless rescinded or repealed.
